**AMENDED MEMORANDUM OF ASSOCIATION OF COMMUNITY ACTION NETWORK
LIMITED .**

1. The name of the company is " COMMUNITY ACTION NETWORK LIMITED".
2. The registered office of the company will be situated in Uganda.
3. The objects for which the company is established are "
 1. To be a not for profit making, non-partisan and non-religious denominational organization.
 2. To improve knowledge of the beneficiaries through imparting practical skills and education that can make them entrepreneurs as well as empowering the youth with little and or no chance of formal education with basic technical/vocational skills through carpentry, tailoring, metal fabrication/works, animal husbandry, community mobilization, sensitization and training and counselling, farming, hair dressing, craft making and value addition.
 3. To provide scholastic materials, educational services, construct and provide premises for educational purposes.
 4. To improve and promote food security in OVC households by not only helping them meet their basic needs but also equipping them with skills that create financial independence.
 5. To promote school attendance and literacy among OVC's with a bias on the girl child.
 6. To create lasting partnerships among stakeholders in schools, vocational institutions and other tertiary institutions through creation of avenues of communication and monitoring of OVC's.
 7. To engage in herbal medicine extraction and training.
 8. To engage in the business of Cosmetics and cosmetics production
 9. To carry on the business of Environmental protection training.
 10. To establish plantation sites for local tress, natural herbs and other local species.
 11. To increase general awareness among all categories of people on HIV/AIDS and its related problems with specific attention to children.
 12. To educate and revitalize minds of all youth about HIV/AIDS and its effects on their families.
 13. To fight stigma and discrimination among and or against under privileged inhabitants of Mbarara and at the places of work among children and women in a particular and the youth.
 14. To promote and create awareness of child health, nutrition, value of physical exercise and fight malnutrition among children.
 15. To increase collaboration plans with other organizations, bodies or individuals whether national or international but having advocacy strategies for the similar cause as laid herein.
 16. To increase awareness about the acceptable health standards among youth, the next fathers and care for children suffering from other opportunistic infections.
 17. To empower youth with the basic information communication technology (ICT) skills thereby equipping the youth with basic computer knowledge thus raising their standard of ICT knowledge and thereby better positioning globally.
 18. To have and cause the organization be registered in accordance with the laws and regulations governing NON-for-profit Organizations.
 19. To work with other concerned organizations in prevention and reduction of malnutrition amongst OVC's.
 20. To promulgate and inculcate life skills into children and youth through sports, music and drama activities.
 21. To do all such other lawful matter and things, to take all lawful steps as may be necessary to protect and safeguard the interests of its members for the attainment of the company objects in line with the laws of Uganda.
4. The liability of the members is limited.
5. Every member of the company undertakes to contribute to the assets of the company if it is being wound up while he or she is a member, or within one year afterwards, for payment of the debts and liabilities of the company, contracted before he or she ceases to be a member, and the costs, charges and expenses of winding
